- Upholding high ethical values and behavioural standards though he may be intellectually controversial.
- Such a person is likely to be past the normal age of superannuation.
- Organisation must be an entity operating in India
- An Awardee from the same family having received an Award earlier be considered only after 5 years.
- Nominations of individuals from their own organisation will not be considered.

- Contribution to the positive evolution of Government policy and ability to establish the right equilibrium between business and its external environment in today's context of liberalised economy.
- The Organisation must be an entity operating in India and the business must have contributed substantially to the growth and development of the Indian Economy.
- Contribution towards globalization of Indian economy and industry.
- An Awardee from the same family having received an Award earlier be considered only after 5 years.

Criteria for Evaluation

- Awareness of and commitment to nationally important issues.
- Commitment to Social Responsibility and Environmental Preservation.
- Concern for the downtrodden segments of society.
- Individual's philosophy, moral values, ethics, integrity and consistency towards work culture.
- Managerial and Leadership Skills which could be imbibed by others in their respective working culture.
- Innovativeness in Approach, effective service and tangible contribution to social, civic undertakings through personal initiative.
- Exceptional Caliber in performance and delegation of duties particularly under adverse environment.
- Strong influence on peer group.
- Involving the opinion leaders to support the chosen cause of Public Service.
- Capability to influence the business community and general citizens for supporting the cause through voluntary contribution of efforts and finance.
- Creating awareness amongst general public (user group) and involving them in the task of actually supervising the work and motivating workers as well as other members of the public.
- An Awardee from the same family having received an Award earlier be considered only after 5 years.
- Nominations of individuals from their own organisation will not be considered.
- Who have done yeoman service in improving Public Life.
