

The Foundation Day souvenir was also released by guests of honour. About 300 business leaders, management experts, academicians and students joined the occasion.













Easy-riding

There is saying that whenever a Madrasi (Punjabis' omnibus term for all those south of the Vindhyas) child is born, his feet are towards Delhi; because sooner or later he's going to land up there! Our Central Government is so full of these brainy guys. However, what a North Indian usually associates a Madrasi – Tamilian to be precise – with is neither his survival instinct nor his intellect but his frugal nature!

I remember the hilarious story our late friend Hari Hiranandani used to tell about the time he travelled to Madras by G.T. Express. There was our Sindhi Bhai – resplendent in a three-piece shark-skin suit – boarding the first class coupe half an hour before departure time, so that his porter could safely bring in his hold-all, suit case, food basket, surahi of water, reading material etc. Then he had to arrange for ice slabs, order tea, breakfast... a hundred details to be attended to.

And, precisely two minutes before the train was to steam out of New Delhi station, in walked a Tamilian clutching a small duffel bag under his arm, and sat down beside our friend. Hari was worried. He thought the guy had boarded the wrong train; he couldn't be undertaking a 48-hour journey without luggage; in any case this little fellow in chappals and lungi couldn't be a first class passenger. But before he could voice his concern the train had started and our man was engrossed in his newspaper.

Come dinner time and Hari had his 'dastarkhan' laid out – plates, cutlery, hot case, napkin, everything was there. A perfunctory "would you like some dinner" and he proceeded with the serious business of eating. Meantime, the train stopped at a small station; our South Indian friend got down, grabbed something from the platform vendor and his dinner was over. He climbed on to the upper berth, spread his lungi like a sheet and was fast asleep before Hari Bhai could even finish his meal.

Morning, while Hari was still laying out his shaving kit, towels, dressing gown, etc, our friend from down South had a quick bath, dried himself with his lungi and then


proceeded to dry it by tying it to the window bars. Soon he was again ready for the day with the clean white lungi tied round his waist, this time double-folded, perhaps more appropriate for the hot day.

The same story was repeated the next night and the following morning while our Sindhi 'gentleman' meticulously went through the motions of changing clothes, getting his bed made and rolled up, ordered and devoured elaborate meals and complained generally about the lack of ice slabs and the discomfort of travelling. But the guy in the multipurpose lungi was at peace with himself. He ate quick small meals from the platforms, read voraciously during the day and slept like a baby at night.

Finally, they reached Madras. The Tamilian clutched his duffel, waved good bye and walked out while Hari waited for a porter to carry his luggage. He was quite distraught seeing no red-shirted ones around when a funny little fellow in doubled up lungi and no shirt walked up and asked if he needed porters. "Yes. Where?" said Hari. "Here", said the little man and waved in a few others when he saw that the 'suited-booted' saheb had lots of luggage.

One picked up the holdall, another one the suit case, the third one the surahi and fourth the food basket. Finally, when the fifth looked sad having found nothing to carry, Hari, generous to a fault, couldn't see this; he handed over his Reader's Digest to the guy and said, "Here, you carry this, my good man."

Already dumbfounded by the amazing companion in his multipurpose lungi, Hari's bewilderment was complete when he stepped out and found our man being garlanded by a whole lot of people. Then he read a banner and realised that he had travelled for two nights with a well-known industrialist of Tamil Nadu!

A Bolder Vision for Business Schools

The basic model for modern management education dates back to the late 1950s. It has been an adaptable, resilient model that has generally satisfied the needs of both students and their employers — in terms not only of courses but of the ideas generated through the research of business faculty. Without business schools, many of the management frameworks and concepts that we take for granted would not exist: from Michael Porter's Five Forces, to the Nobel prize-winning work in asset pricing and Finance, to

Clayton Christensen's concept of Disruption, to Blue Ocean Strategy, or the now-debated concepts of agency theory.

Against this backdrop, there are growing societal pressures for business to take a lead in finding solutions to the climate crisis and to be an agent of social change. As this pressure mounts, the traditional business school model is looking dated. The pace of change in business schools is far slower than in business, with the result that MBAs are



increasingly less well prepared for the complex challenges of leading companies and collective enterprises in general.

To remain a "force for good" for the next decades, business schools need to confront the challenges business faces, and orient their teaching and research accordingly. These challenges fall into three categories:

The Multiplicity of Stakeholders

As firms are called to be more purposeful and more attuned to a broad range of stakeholders and trade off their interests...

...so business schools need to research and teach the skills required for stakeholder capitalism. The Business Roundtable statement or Davos Manifesto are statements of intent for firms to acknowledge and advance the interests of multiple stakeholders, rather than simply accept the primacy of shareholders. To turn these good intentions into reality, business schools should:

- Teach students to understand the nature and implications of stakeholder capitalism.
- Create courses that allow students to understand the needs and concerns of all stakeholders, rather than treating them as instrumental groups to be dealt with in the service of enhancing shareholder value.
- Create new metrics to capture the degree to which firms are addressing the needs of their broader constituencies.
- Research and design new feedback mechanisms (e.g., new forms of management accounting and stakeholder accounting, new measures of investment performance, new contractual structures to create incentives for advancing stakeholder interests, etc.).

Beyond these obvious changes, stakeholder capitalism requires firms to make even more explicit tradeoffs between various stakeholders. While governments may provide some guidance, firms will increasingly have to decide who will benefit. In making these choices, business leaders will be called to administer fairness.

Consider the implications of this. The term "administration of fairness" is the definition of justice. That means we are now asking MBA graduates, who have historically been tasked to administer business (the BA part of MBA), to make determinations about what is and is not just.

Unfortunately, traditional MBA toolkits, whether grounded in economics, data science, or psychology, do not adequately prepare students to think through issues of justice, which means that business schools will need to revisit and broaden their curricula. At the very least, they will need to expand the range of thinkers and teachers on their campuses to include people with backgrounds in history, philosophy, and the humanities. Justice is much more nuanced than net present value.

The Reality of Climate Change

If firms are being asked to combat climate change urgently, not only individually but also in concert with one another, government and civil society...

... then business schools needs need to urgently prepare students to address these issues. The science behind climate change should be taught in business schools, expanding the MBA curriculum and the range of disciplines we include yet further. If investors are to incorporate environmental concerns into their investment criteria or net present value calculations, then we as teachers and thinkers must figure this out and show them how to do that.



But beyond equipping our graduates with an expanded management toolkit, we also have to teach future business leaders how to collaborate with others in order to achieve larger social goals and system change. That means taking a look at how we balance the two core drivers of success: competition and cooperation.

For most schools, competition remains the dominant driver. The bible of business education since its publication in 1980 has been Michael Porter's famous book, Competitive Strategy. It a handbook for success in win-lose environments. To be sure, there has been some movement away from this: Porter's later work, Competitive Advantage, and his notion of shared value acknowledge the possibilities of collaboration, as does the 1996 landmark, Coopetition by Adam Brandenburger and Barry Nalebuff. Nevertheless, it is fair to say that business education still focuses more on competition than on cooperation, providing recipes for private success rather than public benefit.

This is not sustainable. The problems of 2020 are ones that require changes in entire systems: For example, food, water, energy consumption, and supply chains all contribute to climate issues. If we want our students to lead system-level change, they need to understand how complex systems work and how many different forces intertwine to produce nearly intractable problems. This will not be done in short cases studies or powerpoint presentations. Students need to think in terms of horizons that extend past their roles in their jobs and will require multiple generations to solve. They need to understand the needs of their counterparts in other sectors and find ways to negotiate, mediate and collaborate. None of these skills is central in most business school curricula today, but all need to be.

The Necessity of Inclusivity

As firms are being called to become more inclusive...

... then so must business schools. The extant research amply demonstrates that more diverse environments produce better outcomes. Beyond this reality, we need to admit and educate today the leaders for a quarter of a century from now. Where will the world need greater management and leadership skills in 2045?

Many schools are working to achieve greater gender balance, but we will need to do much more. The global business leaders in 2045 will almost surely will not be 60 to 70% American — the current composition of most U.S. business schools. Therefore, we need to proactively reach out now to find and train talent in those regions where management skills will be in greatest need in a generation. At our school, this manifests itself in having 13% of our class from Africa, rather than the business school average of 2%. This commitment is not only to benefit the future leaders of that continent, but also to ensure that the other 87% of our class learns about an important part of the world.

If we are serious about the need to be more inclusive, we need to reject outright the current metric of success for MBA rankings: salaries. The salaries of MBA alumni three years from graduation account for 43% of the Financial Times Ranking and a larger fraction in other rankings. Yet the Financial Times' own data of MBA graduates shows that men make 16% more than women three years after graduation. And I know from our data that geographic and sectoral differences are even more extreme.

Those of us leading business schools often claim that we seek to increase diversity, and we argue on editorial pages that businesses have to wean themselves from share price dominance. Why,



then, do we continue to allow others to measure our success in ways that celebrate homogeneity in gender, geography, and industry? To compound the hypocrisy, these metrics are typically featured in the same periodicals in which we proclaim the virtues of diversity and inclusivity.

In the decades after World War II, stable national governments and peace enabled business to build private prosperity. Business schools were an important contributor to this story. During and following World War II, some business schools

showed great bravery in innovating to win a war and then to win a peace that lasted for generations (see, for example, Cruickshank's history of Harvard Business School).

Here in 2020, business is faced with a greatly expanded mission and so, therefore, are business schools. Both can innovate to generate long-run planetary prosperity. Society demands no less and the leaders of business schools need to show the same bravery that our predecessors did eighty years ago.



Why Working from Home Is a "Future-Looking Technology"

A Stanford GSB expert shows how companies and employees benefit from workplace flexibility.

Are offices outdated? One company found a work-from-home policy increased its bottom line. I iStock/Izabela Habur

But Stanford Graduate School of Business professor Nicholas Bloom says requiring employees to be in the office is an outdated work tradition, set up during the Industrial Revolution. Such inflexibility ignores today's sophisticated communications methods and long commutes, and actually hurts firms and employees.

"Working from home is a future-looking technology," Bloom told an audience during TEDxStanford, which took place in April. "I think it has enormous potential." To test his claim, Bloom, with co-researchers James Liang, John Roberts, and Zhichun Jenny Ying, studied China's largest travel agency, Ctrip. Headquartered in Shanghai, the company has 20,000 employees and a market capitalization of about \$20 billion.

The company's leaders—conscious of how expensive real estate is in Shanghai—were interested in the impact of working from home. Could they continue to grow while avoiding exorbitant office space costs? They solicited worker volunteers for a study in which



half worked from home for nine months, coming into the office one day a week, and half worked only from the office.

Bloom tracked these two groups for about two years. The results? "We found massive, massive improvement in performance — a 13% improvement in performance from people working at home," Bloom says.

Two reasons led to that uptick: First, people working from home actually work their full shift. In the office, people might be delayed by traffic, take a long lunch with a colleague, or leave work early to let a repair person in. They are less likely to be on the clock for the full workday.

Second, Bloom says, people at home are able to concentrate better. "The office is actually an

amazingly noisy environment. There's a cake in the break room; Bob's leaving, come join. The World Cup sweepstakes is going. Whatever it is, the office is super-distracting."


Also, his study found that resignations at the company dropped by 50% when employees were allowed to work from home. "Not only do the employees benefit (by working from home), but the managers benefit because they can spend less of their time painfully advertising, recruiting, training, and promoting."

Bloom says the experiment led Ctrip to roll out a work-from-home option to all its employees. The company reported that it made about \$2,000 more profit per person at home, Bloom says.

Bloom hopes this example helps kill the negative stereotypes of working from home. "For employees, they're much more productive and happier. For managers, you don't have to spend so much time recruiting and training people. For firms, you make far more profit. For society, there's a huge saving of reducing congestion, driving times and, ultimately, pollution.



Some Innovative Ideas To Extract Air Pollution from City-Roads



Various steps are being taken around the world, ranging from USA up to Japan, to deal with this problem. In some of the cities privately owned vehicles are banned from entry into the city-center. The latest of these steps being currently being applied in our own country is the 'Odd–and-Even' Number-Plate formula to re-strict driving on the roads on alternate days of the week.

The pollutants in the city air consist of dust; hydrocarbons—burnt or un-burnt; smoke; and polluting gases. Dust can come from sand deserts,

blown in by the wind; or, from the construction sites. The hydrocarbons occur in the air owing to the exhaust from vehicles. This consists normally of the burnt fuel. Even more polluting can be the un-burnt fuel being emit- ted in the exhaust of 2-STROKE vehicles (scooters); and vehicles having worn-out pis- tons rings and cylinders. You may notice the smoke coming out prominently on the top of a flyover, where the load on the engine is the maximum. The hydrocarbons from diesel vehicles are found to be much more harmful, as compared to those from petrol-vehicles.



Let it be clear right from the concept level that no short- term ideas are being offered here. All the ideas that follow require long-term planning, and adequate arrangement of funds for their implementation. These would involve mandatory modifications to vehicles.

This is to assure that all the ideas proposed here are technically feasible. The only question could be the finan- cial viability and the will on part of the Government and the vehicle-makers.


Filtering Ducts placed on Top of the Commercial Vehicles.


We all know that all air-condi-tioned vehicles have a filter in the front, leading the filtered air to the compressor. The same idea is being proposed here, but on top of the bus or the truck (it being a truck with a top). There would be a power-driven fan at the top front end of the vehicle, with a tubular duct laid along the length of the truck, ending into a filter. In fact, there could be a number of such ducts laid out parallel to one another, each one of these leading to its filter at the end or, alternatively, a single large duct with a rectangular open- ing in the front.

This means that the same vehicle that pollutes the road is made responsible for scavenging the air above it. Such filters would remove all particles of size above 5 microns passing through. The dirty filter could be replaced with a fresh one at the end of the duty-shift.

Portable Electro-Static Precipitators mounted on Top of the Commercial Vehicles

ESPs or Electro-Static Precipi- tators were created originally to bring down the coal-dust rising through the chimneys of thermal power plants. In this case, the particles get electrostatically negatively-charged as these pass between two parallel plates, and go to stick themselves to positively-charged collection-plates; or are brought down from the atmosphere by induction-caused high-frequency vibrations. This would mean that at the end of the journey the top of the vehicle would require either wiping or washing down the particles collected.





There would be a mesh wide enough to cover the width of the vehicle, laid out along the length of the vehicle, followed by the Portable ESP mounted at the end. This would mean an extra load for the vehicle, as well as extra- fuel consumption due to the airresistance caused by the super-structure mounted on the vehicle. Despite this handicap, should the idea result in the removal of the particulate matter from the air, it would be worthwhile implementing it.

Cleansing the Air with a Spray of Water emitted from a traveling open-top tanker

Some of us are aware that till a few decades back, it was usual to see a passing tanker sprinkling water on the dusty roads. Many of us know that after it rains, the pollution level goes down. The drops of water bring down not only the particulate matter but also absorb the toxic gases, to some extent.

Let us now imagine a slow- moving, open-top water tank- er passing along the road. It would be having several tubular structures rectangular in shape, about 2 meters high, placed across the width of the truck. The pipes would have perforations, with water pumped from below trickling down from the top. It would be like a vertical spray from the top pipe, with holes 10 mm. apart.

Filter cloth lengths would be

hanging on both sides of the horizontal pipe on the



top, getting wet with the spray. In this way, 4 or 5 VERTICAL filters placed 1 meter apart would make the air pass through them as the vehicle moved forward.

As the tanker reached the end of its journey, the level of water in it would have gone down; reduced mainly by the amount sprayed that remained in the air; further down by the amount that evaporated. It would then be required to drain out the dirty water, and to replenish the empty space in the tanker with a supply of fresh water. The amount of dirt collected would be indicative of the pollution removed from the city road.

Making the city 'Out-of- Bounds' for Incoming Diesel- Driven Trucks

We all know that ships voyag- ing in the sea never reach the sea-beach, but these get berthed some distance away from it. The material carried on the ships is brought to the shore on barges, or in smaller boats. Let us apply the same analogy to trucks traveling between the cities.

Diesel-operated trucks bring- ing in the supplies should terminate their journey at the periphery of the city. From there the goods should be transshipped to the city though the use of CNG-operated mini-trucks; or through electrically operated vehicles. As an off-shoot, it would also expose contraband material, if any, being brought into the city from border towns. This would also help the police to monitor possible terrorist activities.

Proposal To Remove All Taxes For Min. 1 Year On Electric Vehicles

Taxes are levied on all passen- ger and commercial vehicles, by the Central and the State governments. These include Excise Duties and Sales-Tax. It is suggested here that if the government bodies could make a sacrifice of the tax-earnings for one year

(min.) on Electrically-driven vehicles, it would serve as a great incentive for the people to switch over to this mode of transport.

Battery-Exchange booths could be permitted at various points in the city, where the users could exchange their spent battery for a charged one on payment.

The government would be able to make up the loss of revenue by having saved some money other-wise meant to be spent on health schemes to treat the people affected by pollution. After seeing the results, the scheme could be extended year after year. This would make our future generations grateful to the nation for having taken appropriate and timely care of them.


