

# How People Redirect Their Careers After Getting Laid Off

In today's economy, job loss has become everyday business, ranging from individuals losing their entire firms due to bankruptcy, to losing their jobs because of layoffs, technological disruptions, mergers, and other types of reorganizations. Hundreds of thousands of organizations, ranging in size from small businesses to large firms, file for bankruptcy every year. According to a 2018 Bureau of Labor Statistics survey, between 2015 and 2017, three million workers were displaced from jobs they had held for at least three years. To thrive in their careers,

professionals need to learn how to bounce back from these devastating losses.

Our research on the career trajectories and mourning patterns of former Lehman Brothers employees indicates that those responding to job loss tend to follow one of two paths as they re-enter the job market. Which direction they take hinges primarily on what they want to salvage from their experiences at their old firm, and has important implications for the breadth of their opportunities going forward.



#### **Recreators and Repurposers**

We call these two groups "Recreators" and "Repurposers." Recreators tend to find similar positions, in comparable types of organizations and industries. For Lehman bankers, this meant securing jobs at other financial institutions, often as bankers. Repurposers, by contrast, typically leave organizational careers to pursue entrepreneurial opportunities, in finance or other fields. For Lehman bankers, this involved launching various types of new businesses, including for example travel, education, and e-commerce ventures.

What accounted for these strikingly different career choices? Contrary to much existing research, it was not differential access to resources such as knowledge, networks, or financial capital. Instead, the differentiator was what bankers chose to "hold on to" from their organization after its bankruptcy that mattered. Indeed, rather than focusing on what they lost, both Recreators and Repurposers concentrated on what could they "salvage" from their experiences in their former company.

Recreators had formed tight, almost familial, bonds with their coworkers, and thus sought to recreate this "magic" in similar organizations, doing similar things, with similar — and sometimes the very same — people with whom they had worked at Lehman. To quote one of the participants in our study, "... to be honest, being able to keep working with my colleagues was the most compelling reason [to stay in banking] — to do the same thing with the same people."

Repurposers, by contrast, held on to the entrepreneurial culture of the organization and the skills that they had learned. Their work relationships were professional and cordial, but they did not prioritize maintaining them after the bankruptcy.

These individuals sought opportunities to use those skills in new and different ways. In explaining his decision to become an entrepreneur, another former Lehman banker commented, "...my skills are probably in excess when I'm in a bank, but I can use them profitably when I work with a startup. So when I apply the same set of skills to a startup I can accelerate a lot more its growth."

These paths are not unique to Lehman Brothers' employees. For example, unpublished work by Yale researchers Winnie Jiang and Amy Wrzesniewski suggests that in an occupation where jobs are becoming increasingly scarce, journalists followed either a "preservation" (akin to recreating) or a "reinvention" (akin to repurposing) path as they moved forward with their careers.

We also interviewed executives in other industries who had recently been laid off and successfully bounced back. Similar patterns emerged from these conversations. For instance, "Joe," now the head of investor relations at a biotechnology firm, followed a Recreator path. He described the people he worked with as the most important factor in his career choices, wanting to recreate the family-like culture he had experienced in his previous firm. By contrast, "Stan" became a Repurposer: once a senior financial auditor, he now runs his own consulting practice. In explaining why, he implied the importance of the skills he had learned as an auditor and how he could rely on them to make new opportunities for himself.

#### **Building Broader Horizons**

So which pathway — recreating or repurposing — is better? One consideration, of course, is the number of positions available that might match one's previous job. In particular, in light of layoffs and bankruptcies, there may be a flood of individuals with similar skill sets vying for a limited amount of positions. Thus,



Repurposers may ultimately have the broadest set of opportunities when moving from one job to the next. That said, our research suggests that either path may ultimately be successful; the key is taking the time to consider what you can salvage from your previous job and how to use it to get your next one.

The executives we interviewed echoed the themes in our research, and provided strikingly similar advice on how to successfully bounce back from job loss: take stock, hold on, and let go.

• Take stock of how you feel, what you value, and what you have gained from your past work experience. According to Joe and Stan, respectively, "It takes time to process job loss, you cannot understand a lot of things in that moment." "Take time to figure out what matters to you... create the space for grieving, but do not let that paralyze you. You have to realize that there are a lot of things that you do not lose when you no longer have a job."

• Hold on to what you value and let go of all other parts of your experience. To this end, Joe noted, "You can find some of what you had before elsewhere. Although it will not be exactly the same, it will eventually become a new normal. You can still hold on to some of the things that are important to you, but you also have to realize that that organization is moving forward without you, you are no longer there." Similarly, Stan, explained, "Do not wallow in your sorrows, think forward. There are always new opportunities ahead."

In sum, work loss can be generative when appropriately mourned. As our research indicates, how one bounces back relates closely to how one processes loss. It is in the very processing of loss that movement occurs: from focusing on what is lost, to what is gained and can be re-used in a new job.

# Don't Let Artificial Intelligence Pick Your Employees

A Stanford GSB scholar shares why algorithms aren't sophisticated enough to make these strategic decisions ... yet.

Implicit in his comment is the notion that, someday, these systems will be ready. But work by Adina Sterling, an assistant professor of organizational behavior at Stanford Graduate School of Business, questions this optimism, linking it to a deep — and deeply problematic — misconception of hiring's strategic role.

In a new paper coauthored with Daniel W. Elfenbein of Washington University in St. Louis and published in Strategy Science, Sterling articulates how smart hiring is inextricable from long-term corporate strategy; she also explains why delegating the responsibility of hiring to machines, at least in the near future, is likely to undermine its strategic potential.



"With technology increasingly stepping into this role, we're at a moment in which these questions of higher-level strategy ought to be of great importance," she says.

#### From Monster.com to Algorithmic Hiring

The use of machines in hiring became widespread roughly a quarter-century back, when career platforms like Monster.com emerged on the web. These websites allowed companies to speed up the pace and expand the scale of recruitment. Job posts that once might have fielded 20 applicants were suddenly flooded with 200 in a matter of minutes. "The vast majority of the work since then has been focused on this sourcing side," Sterling says. "It's been about filling up the pool with applicants that you think you need and separating them from the ones you don't."

Today, between 65% and 70% of all job applications are touched first by a machine. After an initial culling, the best-fit candidates are then, in most cases, handed off to a human. And while computers are getting better at understanding information, and while the availability of information is exploding from our online footprints, the relatively strict filtration offered by most sourcing algorithms creates a problem. "It's becoming much harder to find unusual talent, given these candidates don't fit squarely into one category," Sterling says. Consider somebody with a background in improv comedy applying for a sales job: A hiring manager might recognize potential; a computer likely wouldn't.

At the same time, the use of algorithms and artificial intelligence is slowly expanding its purview from sourcing into actual selection. While not widespread, the development of this practice at-scale is on the horizon. "And yet handing sourcing and selection off to machines is a fundamental problem if we start to understand hiring as truly strategic," Sterling says. "There is still a lot that human beings do that has to do with strategy, and scholars need to think through what strategic managers should be doing in the context of hiring."

#### **Hiring as Strategy**

To claim hiring as strategic, Sterling and Elfenbein first define what they mean by this term. A decision is strategic, they say, when it meets four criteria:

Irreversibility: Irreversibility means that once a decision is made the stakeholders are committed to each other, choices available to competitors are irrevocably changed, and some options are necessarily foreclosed while others are opened.

Interdependency: This implies that the benefit of one decision is contingent on relative alignment or complementarity with other decisions made elsewhere in the company. In this regard, interdependency places a premium on knowledge sharing and coordination among decision makers.

Competition: Competition means that competitors' responses influence the value of different alternatives. Decision makers must thus put themselves in the shoes of these competitors and forecast how they might react to each alternative across many imagined futures.

Learning under uncertainty: Companies account for the uncertainty inherent in hiring; they hire not just to execute a new job, but also with an eye to learning new knowledge and getting connected to new people, communities, customers, and suppliers.



After conducting a series of interviews with hiring managers, Al and machine learning experts, and personnel-technology start-up executives, Sterling and Elfenbein argue that each of these conditions applies to hiring, and so it ought to be considered strategic. "And things that you can program or automate — in other words, what machines are already doing in hiring — are not the strategic aspects of hiring. The strategic aspects encompass attending to those four elements," Sterling says.

Hiring strategically thus means thinking not just about any one applicant's skills — the "best athlete" approach — but about how to holistically and consistently source talent and integrate it into the organization. It also means sticking with this human capital strategy over the long term, since these are commitments that cannot be reversed without cost.

In short, hiring is not a one-off search for the most suitable candidate for a specific job, but a process akin to filling a roster. Hiring demands a global view of the company and its direction within a shifting market. Computers do not possess such a view.

#### The Role of Al

This is not to say that hiring algorithms should be discarded. But their role within any HR department,

says Sterling, needs to be squared with the strategic centrality of deciding whom a company employs. This means two things.

First, hiring managers need to take a careful look at what's under the hood of the algorithms they have in place. "There are a lot of filters that any given applicant pool has gone through that managers may have no idea about," she says. "And while algorithms are efficient, they often lose nuance that may have been present 10 years ago when AI was not as prevalent." Consider, again, the sales candidate who excels at improv.

Second, after determining whether these filters need to be adjusted, managers should think about the concrete value of their hiring algorithm. Yes, it sorts résumés quickly. But what else does it do? And what does it not do? They should then fit these insights into broader consideration of the company and its strategic trajectory. How might a blind algorithm support or hinder this movement?

"I would love managers to have the sense that they're held accountable for what algorithms are doing," Sterling says. "They should, at the very least, understand that this is a responsibility of theirs."






