President's Message

Dear Members,

It is my pleasure to present AIMA's Annual Report for the year 2023-24.

Throughout the year, AIMA made significant strides by enhancing existing capabilities, implementing new strategies, and launching a range of new initiatives. These efforts have fortified AIMA's position, setting the stage for sustained growth and enabling it to effectively respond to the evolving needs of its stakeholders.

AIMA continued to be a key enabler of thought leadership by creating opportunities for high-profile interactions among top government and business leaders.

AIMA's flagship events, including the National Management Convention, AIMA Foundation Day/National Management Day, National Leadership Conclave and Managing India Awards, were conducted with the highest standards of excellence.

The National Management Convention (NMC) in 2023 was its golden jubilee edition. This year's NMC focused on making India a vibrant economy and reimagining the Indian dream, and was addressed by an array of celebrated leaders from the government, business, arts and social work. Mr Nitin Gadkari, Minister for Road Transport and Highways conveyed his congratulations to AIMA on its NMC's golden jubilee.

A key highlight was the 'Colours of India - Golden Jubilee Gala Evening,' a special event to commemorate the 50th edition of the convention. Mr Amitabh Kant, G20 Sherpa of India was the Chief Guest at this vibrant tribute to the convention's legacy and enduring significance.

The 68th Foundation Day of AIMA, which is also India's National Management Day, was celebrated with a renewal of commitment to develop India's management talent. Mr Dharmendra Pradhan, Minister of Education, Skill Development, and Entrepreneurship, and Mr Amitabh Kant, addressed AIMA on this occasion. AIMA's marguee awards were also presented, which included the iconic AIMA-JRD Tata Corporate Leadership Award, which was presented to Mr Sanjiv Bajaj, Chairman & Managing Director, Bajaj Finserv Ltd. The AIMA Lifetime Achievement Award for Management was conferred upon Mr Uday Kotak, Founder & Director, Kotak Mahindra Bank and the AIMA Public Service Excellence Award was presented to Mr R A Mashelkar. In addition, the AIMA - Kewal Nohria Award for Academic Leadership, the AIMA - Dr J S Juneja Award for Creativity and Innovation in Micro, Small & Medium Enterprises and the AIMA Ram Tarneja Award for Best Article in Indian Management were also presented on the day.

The National Leadership Conclave (NLC) and Managing India Awards (MIA) took place in April this year. The 9th NLC centered on unshackling leadership, making it more flexible, agile and adaptable. Several eminent leaders from the forces, industry, academia and media addressed various sessions- some of whom included General Manoj Pande, Mr Karan Johar, Prof Pradeep Khosla, Mr Harsh Pati Singhania, Mr Sanjay Kirloskar, Mr Harshavardhan Neotia, Mr TV

Narendran, Mr Vishal Kampani, Mr Piruz Khambatta, Mr Shiv Siddhant Kaul, Mr Raj Chengappa, Mr Vikram Chandra, Ms Avarna Jain to name a few. The conclave also featured newgeneration unicorn founders Mr Vivek Gupta and Mr Abhay Hanjura as well as young financial influencers, Mr Ankur Warikoo and Ms Rachana Ranade.

The 14th Managing India Awards were equally high profile where the Hon'ble Vice President of India, Mr Jagdeep Dhankhar presented these coveted awards. The winners included Mr Onkar Kanwar, Mr Sanjiv Puri, Mr N Ram, Mr Gopal Vittal, Mr Karan Johar, Mr Ashish Bharat Ram, Mr Vivek Gupta & Mr Abhay Hanjura. The awards also recognise outstanding institutions and this year Hindustan Aeronautics Ltd was among the honoured recipients.

AIMA significantly expanded its global footprint this year by adding new programmes to its international portfolio and exploring new destinations. AIMA introduced the Global Innovation & Management Programme (GIMP) as well as a Women's Retreat at new locations; while also extending the reach of its existing CEO Delegation visits to a new destination-Japan.

The inaugural edition of AIMA's Global Innovation and Management Programme was held in Kuala Lumpur, where participating Indian delegates interacted with the Indian and Malaysian thought leaders. The programme also included site visits to the facilities of drone maker Aerodyne and the control centre of Kuala Lumpur international airport.

'Aspire, Achieve, Inspire' was the theme of the first AIMA LeadHERship Retreat in Colombo. Designed to develop and encourage woman leadership, the programme witnessed eminent business leaders from Sri Lanka and India, address the visiting delegates. Both GIMP and the Women's Retreat were kicked off with an inaugural address by the Indian High Commissioners of the respective countries.

Further, AIMA took a CEO delegation to visit Japan for the first time to witness and learn from the innovation trends in that country. The delegation visited Tokyo, Kyoto, Osaka, and Sendai and witnessed the advances in electronics, robotics, automotive manufacturing, and green technologies. The delegation also met with the Indian Ambassador to Japan.

While extending its global footprint in Asia, AIMA consolidated its foothold in the US. In another first, AIMA organised not one but two editions of its distinctive Global Management Advanced Programme (GAMP) this year - a summer and winter edition - in California. This unique programme offers business leaders valuable insights into emerging trends and innovative business models. Some of the iconic companies visited by the delegates included Meta, NVIDIA, Experian, Siemens, IBM, Mercedes-Benz, Salesforce, Chevron, Palo Alto Labs among others.

AIMA held its 6th US-India Conference in California in collaboration with the University of California, Santa Cruz. The conference was addressed by diplomats, business leaders, academics, and technology innovators.

Besides the CEOs delegation visit to Japan, another such visit was also organised to the Silicon Valley. The delegation

visited several innovation-leading companies and institutes, including Google, NASA, Stanford University School of Medicine, Prysm Systems, Gilead Sciences, X the Moonshot Factory, Stanford Doerr School of Sustainability, Mighty Buildings Inc, Bloom Energy, and Joby Aviation.

AIMA sustained its collaboration with European think tanks - St Gallen Symposium and Horasis. AIMA was a co-organiser of the Horasis India Meeting in Adelaide in November last year, featuring a dedicated session economic outlook of India and Australia within the global context. Additionally, as the India partner of the St Gallen Symposium, AIMA actively participated in its 53rd edition held in Switzerland.

A long time and important member of the Asian Association of Management Organisations (AAMO), AIMA continued its regular participation in the bi-annual Council Meetings, held in Kolkata and Hong Kong during the period. In addition, AIMA signed a MoU with Hong Kong's Asia CEO Community, to explore areas of collaboration and best practice sharing.

AIMA also organised comprehensive in-depth trainings and workshops with the World Bank in Sri Lanka and Nepal, which witnessed a remarkable turn out.

Closer home, AIMA continued its regular management and leadership development programmes, including its popular 3-day Retreats at Goa. This year, AIMA successfully hosted a Senior Leadership Retreat and two editions of its HR Retreat, both receiving positive feedback. More such programmes are being planned in the months ahead. A Vice Chancellors Retreat was also organised for the first time in Varanasi.

The LeaderSpeak Series maintained its momentum, with 71 editions held till date. These sessions have garnered substantial popularity, attracting large audiences from across India on multiple digital platforms.

In addition to all the above, AIMA successfully conducted its Global Procurement Summit, Business Responsibility Summit, HR Power Workshop, PSU Summit, Innovation Practitioners' Summit, MSME Convention, Pragati, Shaping Young Minds Programme, Leadership Development Programmes, National Level Competitions & Quizzes, and Business Simulation programmes.

A key new initiative this year was the AIMA-KPMG Women Leadership in Corporate India Report. The report was conceived as a scorekeeper of the progress of women's presence in leadership roles in Indian organisations. The report was brought out in collaboration with KPMG in India and AIMA plans to conduct this study regularly and help Indian organisations devise strategies for greater gender equity.

Education is at the core of AIMA's identity and services. AIMA has always strived to offer the latest and the best management knowledge and knowhow to executives and fresh graduates. Over the year AIMA has revised its curricula to align with the demands of the new economy and evolving business models, while also adding new courses to it product portfolio.

AIMA has expanded its offerings with a PGDM in Financial Planning, along with courses in BFSI and Investment Banking. In the realm of new age technology, AIMA launched an advanced PGCM in Data Analytics and AI Applications,

as well as courses in Cyber Security, Forensics, and Cyber Laws. AIMA has also developed an executive masterclass for business owners and leaders, as well as an aviation services management course using IATA certified trainers.

AIMA also signed a Memorandum of Understanding with one of the country's elite colleges, St Stephen's College, Delhi University, to collaborate in developing education and training programmes for students and executives.

Management research and case compilation is a key area for AIMA. AIMA undertook research on organisation readiness for implementation of AI/ML and it identified resources to offer training to corporates and governments in this area. The positive reception of AIMA's research report indicates a significant new opportunity in this emerging area of management.

AIMA's India Case Research Centre (ICRC) is becoming a key resource for case writing in India. The Centre is developing company-specific cases, collaborating with corporate members and business schools, and partnering with other case centres to enhance its market alignment and sustainability.

AlMA's testing and assessment services saw a major revitalisation this year. AlMA refreshed and relaunched MAT as MAT 2.0, featuring improved questions on current business and technology trends. Efforts to enhance MAT's marketing included leveraging social media influencers and expanding communication channels, with the introduction of a chatbot to improve user engagement. During the year, AlMA continued to deliver custom recruitment and admission solutions to several organisations and institutions across the country.

Overall, through the year, AIMA has achieved significant milestones and expanded its global reach while maintaining strong financial stability. The reported surplus of Rs 18.50 crores on revenues of Rs 74.14 crores underscores AIMA's effective management and commitment to financial sustainability. Despite facing challenges from market and regulatory changes, proactive diversification and modernisation of offerings have strengthened AIMA's financial position, ensuring continued support for future initiatives and sustained progress.

It has been a privilege for me to lead AIMA during the past year and I am grateful to all my colleagues in AIMA's Executive Board and Standing Committee as well as the many past presidents of AIMA for their guidance and support. I would also like to commend and acknowledge the AIMA Secretariat and staff for their dedication in enhancing AIMA's efficiency and innovation.

As I step down, I welcome my successor, Ms Suneeta Reddy as the AIMA President for 2024-25. I am confident that she will bring fresh perspectives and energy to AIMA, driving continued progress and ensuring a seamless transition into the future.


VICE PRESIDENT **T V Narendran**

50th National Management Convention



AIMA held its Golden Jubilee National Management Convention (NMC) on 26th-27th September 2023 on the theme 'Vibrant India: Reimagining the Indian Dream'. The event was addressed by eminent leaders, industry experts, media & entertainment stalwarts and entrepreneurs. The two-day convention witnessed the participation of renowned CEOs, startup founders, economists, academia and media.

Women Leadership Report



Leadership in Corporate India Report 2024 at the 9th AIMA National Leadership Conclave in Delhi on 23rd April 2024. This report, in collaboration with KPMG in India, analyses women representation in leadership roles. The report highlights progress in women's

AIMA released the first AIMA-KPMG Women

The report highlights progress in women's representation in leadership positions in Indian organisations over the past five years, with 83% reporting an increase. However, pay parity remains a challenge, with only 50% of women leaders receiving equal pay. Family and caregiving responsibilities are primary barriers, followed by bias and lack of mentorship.

Despite efforts, 77% of organisations see less than 30% of women hired at entry-level positions advancing to leadership roles, indicating a need for targeted interventions. Recommendations include designing leadership development programmes for women and ensuring transparency in leadership evaluations.

The report underscores the importance of mentorship and role models, with 56% of organisations having just 10%-30% women in leadership roles. AIMA aims to continue this initiative regularly to track progress in women's status in corporate India, emphasising the need for organisations to actively promote women's leadership.

The report presents insights from over 400 respondents, with 65% holding CEO/CXO or senior management positions (with a 70:30 ratio of women to men). It is an initiative of AIMA's Women Council, chaired by Ms Preetha Reddy, Executive Vice Chairperson, Apollo Hospitals Enterprise Ltd.

The AIMA-KPMG Women Leadership in Corporate India Report is under the aegis of AIMA's Women's Council - Aspire, aimed at promoting the leadership and growth of women professionals.







Corporate Management Olympiad

AIMA's 6th Corporate Management Olympiad was held online from 7th - 8th May 2024. 90 teams from both PSU and Private sector competed over various rounds of Case Study, Business Modelling, Quiz and Business Simulation Competitions. Quiz & Competition

National Competition for Young Managers

The regional rounds were successfully conducted from 31st August to 22nd September 2023 and the Grand Finale was held on 29th September 2023. The competition was segregated into two different categories - PSU and Private. Testing & Assessment Services

Management Aptitude Test (MAT)

The Management Aptitude Test (MAT) remains the flagship service of AIMA Centre for Management Services (CMS). MAT was conducted in September 2023, December 2023, February 2024, and May 2024, with over 600 B-schools considering MAT scores for admissions. The test is available in three modes: Internet-Based Test (IBT), Paper-Based Test (PBT), and Computer-Based Test (CBT), catering to a diverse range of candidates. International students were also given the opportunity to register for MAT this year.

New Initiatives

MAT 2.0

From May 2024, AIMA introduced MAT 2.0, an evolved version of MAT which covers newer segments like current business and economic trends. MAT 2.0 is a new-age entrance test that offers a fresh perspective on management education aligned with contemporary industry practices and growing educational requirements. The alterations in MAT 2.0 encompass various aspects, including exam structure, content focus, and duration. Notable changes include a streamlined exam structure featuring 150 questions to be attempted within 120 minutes, thereby assessing candidates with a sharper focus on topics covering new-age business areas and providing a more focused and efficient examination experience.

Branding & Marketing

Introducing a new tagline #YourAttemptMATters, MAT revolutionised its branding strategy, positioning itself as a leading and trusted entrance exam. The campaign strategically highlighted the name "MAT," enhancing brand

recall among its target audience. By incorporating influencers into a robust marketing strategy, MAT forged an immediate connection with the youth, aligning closely with the aspirations and mindset of aspirants.

Introduction of Chatbot Mattie

Chatbot Mattie was introduced to enhance candidate experience by providing 24/7 support. With information available at any time, Mattie now promptly addresses basic queries and concerns, ensuring candidates receive immediate assistance at their convenience. Moreover, candidates can now also access essential information through WhatsApp around the clock, thereby enhancing accessibility and interactivity in engagement.

AIMA CMS has expanded its offerings by providing Remote Proctored Internet Based Tests to select clients.


AIMA's Digital Evaluation System streamlines the process of digitising answer sheets, automating workflow, and generating reports for measuring effectiveness and driving process improvements. It minimises costs, time, effort, and human errors in the valuation of answer booklets.

In addition, online Interviews help streamline the admission and recruitment process. These interviews are conducted using a hybrid model that utilises a customised online software or utility tailored to specific requirements, along with the licensed version of the Webex/Zoom Meetings digital platform.

AIMA's e-Counselling System enables candidate registration, document upload, fee payment, document verification, seat allotment, approval, and seat allotment letter generation. It ensures transparency, policy compliance, and real-time seat availability updates. The system supports online payments, communication via email and SMS, and is widely used by National Institutes for admission processes.



Education

Centre for Management Education



AIMA Centre for Management Education (CME) continued to deliver high-quality management education programmes in blended learning mode through e-learning, personal contact classes and workshops. AIMA CME also added several new age courses, increased technology adoption and aligned with prevailing regulatory norms.

Programmes offered during 2023-24 academic year

AIMA offered Post Graduate Diploma programmes during the year including its flagship Post Graduate Diploma in Management; Post Graduate Diploma in Management (Executive); Post Graduate Certificate in Management in Digital Marketing & Strategy, Business Analytics, Public Accounting, Entrepreneurship & Family Business, Alternative Investment and others; Professional Diplomas

in the major functional areas of management including Marketing, Retail Management, International Business, Financial Modelling and Operations Management; Professional Diploma in Public Procurement; Certificate Programme in Contractual Dispute Resolution; Public Private Partnership; Sustainability Management; Digital Business Management; Digital Innovation and Transformation for Enterprises; Business Consultancy and Corporate Social Responsibility.

AIMA - India Case Research Centre

The AIMA India Case Research Centre (ICRC) continued to promote case-based learning in management education. The centre carried out many activities to encourage the professional growth of educators case teaching and writing in the management area.

The ICRC has successfully trained over 2,000 faculty members in case method teaching and writing, significantly enhancing pedagogical effectiveness. To date, the ICRC has developed and published more than 130 teaching cases across 31 key areas of management education.

The ICRC has introduced a dynamic platform showcasing India-centric cases from IIM Bangalore and ISB, with links directing users to the respective institutes' portals for further engagement.

ICRC signed MoUs with The Case Centre, and The HKU Asia Case Centre for various activities. ICRC is also engaged actively with the institutions like MDI-M, SDMIMD, BMS, JIMS, and others to develop faculty capacity in case-based teaching and development, mentoring faculty to publish cases on the ICRC portal with institute branding. Recently ICRC also collaborated with the Capacity Development Commission of India to develop cases on major policies.

Research Projects

AIMA successfully completed the research study on 'Readiness and Interest of Organisations for Adopting Emerging Technologies like AI and ML' by the Department of Scientific and Industrial Research, Ministry of Science and Technology. The report for the same has been submitted to the ministry.

New Initiatives

AIMA has collaborated with Wadhwani Foundation for capacity development of employees of Medium Sized Enterprises in India. As part of this initiative, a series of training programmes covering functional and behavioural aspects of management are planned over the next one year.

Skilling Initiative

Strengthening the efforts of Government of India to make India as a "Skill Capital of the World", AIMA has joined hands with the Management and Entrepreneurship Sector Skill Council (MEPSC), to execute the training under Recognition of Prior Learning Scheme.

As per the mandate, AIMA is conducting onsite training for the specified job roles to the employees of identified companies across the country. This scheme is being run by the Ministry of Skill and Entrepreneurship, Govt of India through various sector skill councils to build a strong skill eco-system in the country.



In addition, AIMA CME has initiated the process of Curriculum Review for the courses offered in PGDM programme to align it with industry needs and requirements. A few new courses in 'Emerging Areas in Technology and its application in Management', 'Entrepreneurship, Innovation and Startups' and 'Sustainability Management and Corporate Social Responsibility' are being included to make the PGDM courses more contemporary. Also 'Self Learning Material' for all the courses are being revised and updated.

Consultancy Project

AIMA has collaborated with Deloitte to implement the 'Consultancy for Capacity Development on Rajasthan Transparency in Public Procurement [RTPP] Act and Rules' for the Government of Rajasthan. The project aims to enhance the capacity of Government officials in implementing the Act and Rules. The curriculum development and training for foundation and specialty courses for 7000 officials has been done. The physical training for speciality courses and foundation courses are completed and MOOC training are currently going on.

AIMA has also successfully completed the project on 'Capacity Development and Training on Contract Management to National TB Elimination Programme/National Health Mission Officials' funded by the United States Agency for International Development (USAID), the Health Systems for TB (HS4TB) project targeted 5 states viz. Orissa, Delhi, Gujarat, Andhra Pradesh, and Telangana. The project encompassed competency assessment, developing learning programmes on private sector partnership contracting processes, and delivering training for the National TB Elimination Programme/National Health Mission Officials in all the 5 states.

Note-22

Significant Accounting Policies and Notes to Accounts

(Annexed to and forming part of the Balance Sheet as at 31st March, 2024)

A. Accounting Policies:

- The preparation of financial statements in conformity with generally accepted accounting policies
 requires management to make estimates and assumptions that affect the reported amounts of
 assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial
 statement and the reported accounts of revenues and expenses for the years presented. Actual
 results could differ from these estimates.
- 2. (a) Inventory of saleable publications and priced printed brochures, books, study material and stationery are valued at cost.
 - (b) Outdated stock of books, prospectus and bulletins etc. is charged off as and when ascertained.
- 3. Interest on investments of corpus funds is added to corpus funds and in the case of earmarked funds, interest is taken to income.
- 4. Depreciation on fixed assets is provided on the following basis: -
 - (i) Premium on the leasehold land is amortized over the period of lease.
 - (ii) Other assets at written down value method at rates as prescribed in Income Tax Act, 1961.
- 5. Accounting Standard-9 Revenue recognition states "revenue should be recognized at the time of sale or rendering of services. However, if at the time of sale or rendering services there is significant uncertainty in ultimate collection of the revenue, then the revenue recognition is postponed and, in such cases, revenue should be recognized only when it becomes reasonably certain that ultimate collection will be made". AIMA has followed the above principle for recognition of revenue except for membership fee and income from sale of prospectus which is accounted for on cash basis consistently.
- Interest income is recognized on a time proportion basis taking into account the amount outstanding and the applicable interest rate. Interest income is included under the head "Other Income" in the Income and Expenditure Account.
- 7. Expenditures are accounted for on an accrual basis.
- 8. Accounting Standard-10 accounting for Fixed Assets states "the cost of fixed assets should comprise its purchase price and any other cost directly attributable to bring the assets to its working condition excluding G.S.T. if Input Tax Credit is to be availed of. When the fixed assets are retired from active use and disposed off then the gain or loss from disposal of fixed assets is recognized in the statement of Profit and Loss or Income and Expenditure Account". AIMA has followed the same principle for accounting of fixed assets.
- 9. Capital work in progress is valued at Cost.

- 10. Intangible assets acquired separately are measured on initial recognition at cost. Gains or losses arising from derecognition of an intangible asset are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the Statement of Profit and Loss when the asset is derecognized.
- 11. Investments, which are readily realizable and intended to be held for not more than one year from the date on which such investments are made, are classified as current investments. All other investments are classified as long-term investments. On initial recognition, all investments are measured at cost.
- 12. Liability for Leave encashment is provided for on basis of valuation from Life Insurance Corporation of India under a Group Leave Encashment Scheme for employees.
 - Similarly, Liability for Gratuity is also provided for on basis of valuation from Life Insurance Corporation of India under a Group Gratuity Scheme for employees. AIMA Employee Gratuity Trust administrates the Group Gratuity Scheme.
 - As AIMA has opted to make contribution to Life Insurance Corporation of India towards Employees Gratuity and Leave Encashment, provisions are created based on information received from Life Insurance Corporation of India.
- 13. Provident fund is contributory. The rate of contribution is 12% of basic salary. The AIMA EPF Trust administers the Provident fund. AIMA EPF Trust shall pay interest at the statutory rate decided by EPFO. Pending finalization of the provision of interest to be credited to the employee's accounts in the books of the PF Trust, AIMA will need to ascertain the amount of contribution, if any.
- 14. All Revenue Grants received / receivable by AIMA during the financial year are credited to Income & Expenditure Account.

B. Notes to Accounts:

- 1. Income tax cases of AIMA for the financial years 2004-05 to 2009-10 were listed for hearing on 12th November 2013 before the Hon'ble High Court of Delhi. The Hon'ble High Court of Delhi has held that the word 'education' has a wider meaning and is not restricted to imparting education to students through classes only. The Hon'ble High Court of Delhi has held that the activity of conducting tests carried out by AIMA is not to be considered in isolation but has to be considered as part of the overall activities carried out by AIMA to further its objective. The cases were referred back to DGIT(E) for review.
 - After reviewing the above order & documents provided by AIMA, the CIT(E) restored the AIMA's Income tax exemption under section 10(23C)(vi) vide its order dated 4th August, 2022.
- 2. (A) AIMA in the past has received two show cause cum demand notices finally confirming the demand of service tax due of ₹ 25.53 crores along with a penalty of ₹ 25.53 crores u/s 78 and u/s 77 of the Service Tax Act. Thus, the total demand inclusive of penalties comes to ₹ 51.06 crores for the period from 2004-05 to 2010-11.
 - AIMA filed a statutory appeal in the CESTAT, New Delhi impugning the above said confirmation of demand by the adjudicating authority.
 - The Tribunal after final hearing of above cases on 10th March 2017 decided in favour of AIMA & set aside demand & penalties vide its order No. 52459/2017 dated 21st April 2017.

The service tax department has since then filed an appeal in the Hon'ble Supreme Court against the Tribunal order and AIMA has received a notice from the Hon'ble Supreme Court on the same. AIMA has filed a detailed counter reply in the Hon'ble Supreme Court on 3rd July 2018 through our Lawyer. Hence the case shall be taken up in due course by the Hon'ble Supreme Court.

(B) Third show cause cum demand notice was issued by the Service Tax Department on 18th April 2013 for ₹ 2.25 crores for the period from 2007-08 to 2011-12.

The reply to the above show cause cum demand notice was filed by AIMA. The show cause notice above was adjudicated and the demand made in the show cause notice was confirmed vide order dated 6th June 2014 along with equal amount of penalty and applicable interest.

Accordingly, the appeal against the above order has been filed with the Tribunal. The final hearing of appeal was held on 31st July 2018 and after final hearing the Tribunal decided the above case in favour of AIMA and set aside demand and penalties vide its order no. ST/A/50124/2019-CU/DB dated 30th January 2019.

The service tax department has since then filed an appeal in the Hon'ble Supreme Court against the Tribunal order and AIMA has received a notice from the Hon'ble Supreme Court on the same. AIMA has filed a detailed counter reply in the Hon'ble Supreme Court in February 2020 through our Lawyer. Hence the case shall be taken up in due course by the Hon'ble Supreme Court.

- (C) The Service Tax Department has issued a fourth show cause cum demand notice on 16th May 2014 for ₹ 4.35 crores for the financial year 2012-13. The basis of demand is same as in the previous three demands.
 - The reply to the above show cause cum demand notice has been filed by AIMA and this case shall be taken up in due course by the Service Tax Department.
- (D) The Service Tax Department has issued a fifth show cause cum demand notice on 13th April 2016 for ₹ 1.54 crores for the financial year 2014-15. The basis of demand is same as in the previous four demands.
 - The reply to the above show cause cum demand notice has been filed by AIMA and this case shall be taken up in due course by the Service Tax Department.
- (E) The Service Tax Department has issued a sixth show cause cum demand notice on 20th April, 2022 for ₹ 4.05 crores for the financial year 2016-17 & 2017-18. The basis of demand is same as in the previous five demands.
 - The reply to the above show cause cum demand notice has been filed by AIMA and this case shall be taken up in due course by the Service Tax Department.
- (F) The Service Tax Department has issued a seventh notice on 20th March 2023 for ₹ 17.18 crores for the financial year 2017-18 to 2020-21. The basis of demand is same as in the previous five demands.
 - The reply to the above notice has been filed by AIMA and this case shall be taken up in due course by the Department.
- 3 (A) AIMA received demand notice from South Delhi Municipal Corporation u/s 123D of Delhi Municipal Corporation Act, 1957 for deposit of ₹ 37,33,518/- towards the payment of arrear on account of house tax for use of Institutional Building as Business Building. The same has been

contested by AIMA before Tribunal and Tribunal waived off interest & penalty of ₹11,98,785/- but retained the balance demand of ₹25,34,733/-. AIMA challenged the order in the Hon'ble High Court of Delhi vide W.P. (C) 2421/2014 & CM No. 5062/2014. The Hon'ble High Court of Delhi has directed AIMA to deposit the above said amount in five equal installments interspersed by two months between each installment. As directed by the Hon'ble High Court of Delhi, AIMA has deposited ₹25,34,730/- with the MCD.

The MCD Tribunal after final hearing of above case on 1st May 2017 decided in favour of AIMA & set aside the above South Delhi Municipal Corporation (SDMC) order vide its order dated 1st May 2017 and directed to SDMC to refund the above deposited amount to AIMA with interest. However, SDMC has impugned the order of the Tribunal before the Hon'ble High Court of Delhi through WP 10758 of 2017 and the above matter is pending for the adjudication in the Hon'ble High Court of Delhi.

- (B) We have received another assessment order & demand letter of ₹ 24.76 lakhs (Property Tax ₹ 19.34 lakhs + Interest ₹ 5.42 lakhs) from SDMC for the period from 2014-15 to 2017-18. We have consulted the above-said assessment order with our advocate and upon their legal advice, we have filed an appeal impugning the assessment order and have deposited pre-requisite predeposit of ₹ 19.34 lakhs in the MCD Tribunal. SDMC has passed the above assessment order on similar grounds, which as per our advocate is not sustainable in law. Now, the above matter is pending for adjudication in the MCD Tribunal.
- 4. Investments are made in securities covered under Section–11(5) of the Income Tax Act, 1961 and are valued at cost of acquisition.
